AFFIDAVIT of PROBABLE CAUSE

Your affiant is a Pennsylvania State Trooper currently assigned to Troop G Rockview as a Criminal Investigator and has been employed as a State Trooper for nearly 12 years.

- 1.) On 11/21/16 at approximately 1600 hours the victims' father arrived at PSP Rockview advising his 17 year old daughter, victim #1 who was 16 at the time, had received text messages from a 41 year old male, Jeffrey SANDUSKY, asking her to take naked pictures of herself and send them to him. The victims' father advised that the text messages in question were sent to victim #1's cell phone and were dated Tuesday March 1st 2016 and Wednesday March 2nd 2016. Victim #1 had saved the text messages from Jeffrey SANDUSKY and had sent them to him (victims' father) via screen shots/pictures on 11/20/16 after victim #1 had told her mother who then told SANDUSKY that he had to leave the residence as he had been living there for approximately 5 years. The victims' father then proceeded to show the text messages to me and then emailed them to me where they were printed off.
- 2.) While reviewing the text messages from Jeffrey SANDUSKY to victim #1 he asks her to send some pictures of her "boobs" and that it's not weird because he studied medicine. Jeffrey SANDUSKY advises victim #1 that nobody needs to know and that she has his word. Jeffrey SANDUSKY then advises victim #1 to not show these texts to anyone. Jeffrey SANDUSKY then asks victim #1 again to send him the picture and advises that it's not for him and that he has already seen her nude. Jeffrey SANDUSKY then again asks for a picture when victim #1 advises she is going to bed and to stop asking her for naked pictures of herself.
- 3.) Jeffrey SANDUSKY then asks her to send a picture of herself in the morning when she is dressing for school and advises her to erase all the texts and that none of this "shit" gets mentioned to anyone or seen by anyone. Jeffrey SANDUSKY asks victim #1 to take a picture of herself while she is changing or taking a "piss" etc. Jeffrey then asks for a picture of victim #1 in her bra and panties then for a topless picture. Victim #1 advises she does not want to and then Jeffrey advises her that they need to talk to get things straightened out. Victim #1 responds by stating; "no we don't need to talk and we aren't going to. You did what you did and I'm not going to give you a chance to try and justify it. You literally tried to guilt me into doing it and you even told me specifically what I "needed" to do. You know who does that? Rapists and Abusers, not stepdads who care about their stepdaughters. I don't know how many times I need to tell you no and to stop before you get it."

- 4.) After speaking with the victims' father, Tpr. WAKEFIELD and I then went to the residence of the victim and the victims' mother. Contact was made with the victims' mother who was explained the reason for the visit and the investigation into text messages received by her daughter, victim #1, from Jeffrey SANDUSKY. The victims' mother advised that she and Jeffrey SANDUSKY have dated for approximately 6 years and he has resided with her and her children for approximately 5 years. The victims' mother asked Jeffrey SANDUSKY to leave yesterday evening when she was advised by her daughters that Jeffrey SANDUSKY had sent text messages to her 16 year old daughter at the time asking for naked pictures. The victims' mother gave permission for Tpr. WAKEFIELD and I to take her daughters cell phone to complete a cell phone extraction. After the cell phone extraction was completed the content was reviewed and the text messages from 03/01/16 and 03/02/16 were printed off between victim #1 and Jeffrey SANDUSKY.
- 5.) On Saturday 12/10/16 at approximately 1655 hours I interviewed the victims' mother at PSP Rockview in regards to this incident. The victims' mother was presented with the cell phone messages between Jeffrey SANDUSKY and her daughter, victim #1, on 03/01/16 and 03/02/16 of this year. While reading through the text messages I observed the victims' mother start to become emotional. The victims' mother advised that Jeffrey SANDUSKY had advised her that he was trying to help her daughter by getting naked pictures of her off the internet and needed naked pictures of her to do it and to "role play". The victims' mother advised that the texts are "fucked up". The victims' mother went on to advise that there were not any pictures of her 16 year old daughter naked on the internet and when she was advised by her daughters of the inappropriate texts she confronted him and asked him to leave. Jeffrey SANDUSKY advised her that he was sorry and didn't remember what he had said and then opened up and advised he knows it was wrong and inappropriate.
- 6.) After speaking with the victims' mother I interviewed her daughter, victim #1, at PSP Rockview at approximately 1750 hours on 12/10/16. Victim #1 advised that she has constantly felt that Jeffrey SANDUSKY has looked at her inappropriately and stares at her but doesn't think Jeffrey has seen her naked. Recently, while she was in the shower, she could hear Jeffrey SANDUSKY walking down the hallway and hears the footsteps stop as if someone is looking into the bathroom. Victim #1 advised that there is a crack near the door and you can see into the bathroom if you are trying to look into it. Victim #1 also related that she now gets a shower while Jeffrey SANDUSKY is at work or not at the residence because she does not feel safe with him there.

- 7.) Victim #1 advised that in regards to the text messages she received from Jeffrey SANDUSKY she has only received texts like this once. The texts were read and victim #1 advised that all those texts were accurate and she received them from Jeffrey SANDUSKY on 03/01/16 and 03/02/16 and recently sent them to her father. The night of these texts she advised she was in her bedroom and that Jeffrey was on the couch and their mother was sleeping. Jeffrey SANDUSKY had advised her that he knew she was doing sexual stuff and that there were naked pictures of her on the internet. Victim #1 advised she knew his talk was "bullshit". Victim #1 advised that the texts that had been sent by Jeffrey SANDUSKY to her were disrespectful, wrong and that he shouldn't be asking stuff like that. Victim #1 advised that the texts made her feel uncomfortable and that he kept pressuring me and asked me multiple times to not show the texts to anyone and to erase them. Victim #1 then advised that she never told her mother initially because he, Jeffrey SANDUSKY, makes my mother happy, however did tell her sister, victim #2, the next day. Victim #1 also advised that Jeffrey SANDUSKY has made sexual comments before to her and stated "he is always looking at me in weird ways, starring me up and down".
- 8.) Victim #1 went on to advise that if she were in the house by herself with Jeffrey SANDUSKY she feels he would try and do something to her and that she does not feel safe with him at the house. Victim #1 went on to advise her sister, victim #2, confronted Jeffrey the next day after she had told her what Jeffrey had done to her. Victim #2 then advised her sister, victim #1, that he had done the same type of thing several years back to her when he asked her for oral sex to "suck him off". Victim #1 advised that her sister was told by Jeffrey that he would never do this again and promised not to do anything like this to her.
- 9.) On Sunday 12/11/16 at approximately 0900 hours, victim #2, now 19 years of age, arrived at PSP Rockview and was interviewed in regards to this incident. Victim #2 advised that her sister had told her the following morning on 03/02/16 about texts that Jeffrey had sent her asking her to take naked pictures of herself and send them to him. Victim #2 advised that she was very upset that Jeffrey had done this and that she asked Jeffrey to go for a drive with him. During the drive victim #2 advised "I tore into him" and yelled at him advising him she knew about the texts her sister had received from him. Jeffrey advised her that it's not what you think and that he knows a guy that could remove naked pictures from the internet. Victim #2 advised she knew he was lying and he couldn't provide me with any name when I asked him and told Jeffrey that this shouldn't be happening. Jeffrey went on to advise her "I can't even say anything except I'm sorry". Victim #2 advised she and her sister didn't tell their mother because they didn't want to put that on their mothers' plate and cause her additional stress.

10.) At this time I questioned victim #2 about messages that she had received from Jeffrey several years ago. Victim #2 started to become emotional and advised that when she was 15 years old in the spring of 2013 she was taking a shower at their house and that her sister and mother had left to go to a softball tryout for her sister. Victim #2 advised she thought it was on a weekend and it was only her and Jeffrey at the house. Victim #2 advised that she had her cell phone in the bathroom with her when she received a text from Jeffrey, who was in the residence at the time, saying "I have a question, don't tell mom". "Would you suck me off"? Victim #2 responded back why would you ask me that? Jeffrey replied back that he wanted to "know how it felt". Victim #2 advised Jeffrey never to say anything like this to her or her sister again and Jeffrey responded "Ok". Victim #2 advised she does not have that phone anymore and did not save the texts because she is trying to forget about it. Victim #2 advised that the text was wrong and he shouldn't be asking a minor for oral sex and that she worries what could or would have happened if he got mad or aggressive.

Based on the information documented within this criminal complaint and affidavit I respectfully request these charges be approved so the defendant may answer to these charges.
