The two straws yielded positive results for Fentanyl. The rubber container yielded positive results for Heroin.</p> <p>After conducting a search of the defendant's vehicle, no illegal items were located within.</p> <p>Post Miranda, the defendant confirmed to be residing at the location, along with her boyfriend (Johb Centella) only. It should be noted Johb has been in custody at the LOL Jail since 1/27/20. The defendant confirmed the shared bedroom to be located in the west side of the apartment. After mentioning the small black rubber container, the defendant made a statement along the lines, "I have seen that before." The defendant also mentioned utilizing a straw for the use of illegal narcotics.</p> <p>The defendant was arrested for possession of a controlled substance (Fentanyl), heroin, and drug paraphernalia.</p>

<p>During a consensual search of the defendant's residence black dishes were located in the sink, which appeared freshly washed. A blue straw was also located in the residence, which tested positive for Fentanyl. Small baggies were also located in the residence and tested positive for Fentanyl. Money matching the above description was located in the defendant's purse along with her Driver's License. The defendant stated in a post Miranda Warning interview she did cocaine with the witness and decedent but denied providing Fentanyl to the witness and decedent. The defendant was arrested and transported to the Land O Lakes Detention Center.</p>
